

Terms and Conditions

- 1. The Manulife InvestChoice Promotion ("the Promotion") is taking place from 3 January to 30 June 2024, both dates inclusive ("Promotion Period").
- 2. Each eligible client opened a new single-name or joint-name Manulife InvestChoice Account online for the first time during the Promotional Period ("New Client") will be entitled for the reward 1, 2 or 3 listed in Item 3 if its conditions(s) is/are met. New Client(s) can receive more than one type of reward and each type of reward can only be obtained once.
- 3. Rewards:

Reward 1: account opening cash reward

Reward 2: Monthly Investment Plan subscription fee rebate

For all monthly fund subscriptions made by New Client(s) during the Promotion Period, the relevant fund subscription fees will be eligible for cash rebates, with a maximum of HK\$1,000. New client(s) must set up a Monthly Investment Plan under the Manulife InvestChoice Account and complete fund subscription successfully during the Promotion Period. The minimum monthly subscription amount starts at HK\$1,000 per class.
