We write to advise you of the following general updates:

**1. Enhanced Processing of Subscriptions paid in other Major Currencies**

With immediate effect, applications in respect of subscriptions by applicants who wish to pay in other Major Currencies will no longer be treated as having been received on the day when the General Adviser and Distributor or the Sub-Administrator (as applicable) has confirmed the receipt of cleared funds, and instead will be processed upon receipt of the application.

**2. Change of name of Sub-Investment Manager of the U.S. Bank Equity Segregated Portfolio**

The name of the Sub-Investment Manager of the U.S. Bank Equity Segregated Portfolio, Manulife Asset Management (US) LLC, has changed to “Manulife Investment Management (US) LLC” with effect from 7 May 2019.
